4. Project/Program Description

In an effort to provide additional downstream water quality improvements to current partially treated areas, the Sanford Airport Authority desires to Permit and Construct a new stormwater management system and enlarge existing systems to provide these improvements. The first area being targeted ultimately drains to Lake Jesup (WBID 2981) which has an adopted TMDL and BMAP for nutrient reductions.

Improvements include additional treatment volume, flood protection measures, and wildlife attractant removal.

Local users and tenants of the airport including the 2.8M travelers to/from the airport in 2022.

Reduced nutrients in the receiving impaired waterbody which will be measured by water quality improvements in the Lake Jesup. The reduced flooding will minimize the risk of airfield impacts during high intensity storm events.
