1. Project Title Palm Beach County Food Bank Produce Processing Facility

4. Project/Program Description

A processing facility that establishes a public-private relationship with local farmers and Child Care Food Program Providers to decrease food waste and increase access to healthy nutritious foods for food insecure people (particularly children and seniors). The initiative partners with local farmers to rescue grade "B" and "C" food and other food that is not sold in the market. The rescued produce is brought into the processing facility where it is processed, cryovac packaged, and cold-stored. The produce is made available to many more agencies and individuals year-round. In addition, We'll partner with Child Care Food Program (Afterschool meals, Summer BreakSpot, child care centers) and Home Deliver-Meal providers to cater their meals, thereby implementing a sustainable revenue and job-generating initiative. There is a need for a large enough caterer that can be certified by FDACS and handle the significant meal demand.

Works with farmers to capture additional produce that may otherwise go to waste and increase its shelf-life through cryovac packaging and increasing access to healthy foods. We'll partner with Child Care Food Program (Afterschool meals, Summer BreakSpot, child care centers) and Home Deliver-Meal providers to cater their meals, thereby implementing a sustainable revenue and job-generating social entrepreneurship. The facility will be made available for culinary training and nutrition education programs.

c. What direct services will be provided to citizens by the appropriation project?

increase access to healthy nutritious food, decrease food waste, culinary training, nutrition education, and job creation.

d. Who is the target population served by this project? How many individuals are expected to be served?

Elderly persons, jobless persons, homeless, school-age children, the general population. The Palm Beach County food Bank serves on average 200,000 people per month.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Will rescue and additional 50,000 lbs of food, decrease food waste, create jobs and feed 2,000 children and seniors. All the data is tracked by our internal tracking system - Microsoft Dynamics Nav. The system keeps track of the pounds of food rescued, and people served.
