4. Project/Program Description

Since 2010, UF has been the managing entity for more than 30 historic buildings in St. Augustine. UF's legislatively mandated mission is: to "ensure long-term preservation and interpretation of state-owned historic properties in St. Augustine while facilitating an educational program that will be responsive to the state's needs for professionals in historic preservation, archaeology, cultural resource management, cultural tourism, and museum administration and will help meet needs of St. Augustine and the state through educational internships and practicums." Consistent with this mission, the requested \$500,000 in non-recurring fixed capital outlay funding will be used to re-purpose the historic Coquina Warehouse. The current unoccupied downstairs area will be rehabilitated into a living learning center that will house students and faculty who come to St. Augustine to engage in research, teaching, and public education programs.

14. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

Coquina Warehouse was reconstructed by the State in 1966 from the remains of a building dating back to the 1800s, for use as a maintenance shop for the operations of the state-owned historic properties in downtown St. Augustine. Since 2010, it has been used for storage and limited construction staging. The expansion and success of UF's research and teaching mission is hampered by the lack of short-term housing in the area. This project will increase access for UF students and faculty participating in the study and expansion of knowledge in archaeology, materials conservation, historical preservation, and sea-level rise in St Augustine.

b. What activities and services will be provided to meet the intended purpose of these funds?

This is a shovel-ready fixed capital outlay project. With a completed Design, already approved by the appropriate Historic Preservation boards, this project can advance quickly to construction, thereby increasing access to living/learning opportunities, in order to help fulfill UF's statutorily mandated educational mission in St. Augustine.

c. What direct services will be provided to citizens by the appropriation project?

Over the past decade, UF has stabilized the deteriorating historic structures; established the Preservation Institute; partnered with an entrepreneur to operate the "Colonial Quarter" (a living history experience serving K-20 students and the general public); completed rehabilitation of Governor's House, including a modern museum gallery; curated the "First Colony: Our Spanish Origins" museum exhibit; expanded public restrooms for support the entire downtown district. A key element in continuing the progress made to date, this project will provide additional living/learning opportunities for UF students and faculty and enriched educational opportunities for Florida's K-20 students and tourists visiting these historical properties.

d. Who is the target population served by this project? How many individuals are expected to be served?

UF students, faculty, staff engaged in research and education in archaeology, materials conservation, historical preservation, cultural tourism, museum administration, and sea-level rise. K-20 students across the state. Persons visiting the Historic St. Augustine properties. Future educational opportunities for serving individual persons are unlimited.
