1. Project Title Hurricane Resilience for World's Best Living Collections of Orchids and Bromeliads

#### 4. Project/Program Description

The Downtown Sarasota campus of Marie Selby Botanical Gardens holds the world's best scientifically documented collections of living orchids and bromeliads, which are studied and treasured by botanists from around the globe. Biodiversity has declined by two-thirds in the past 50 years and Selby Gardens is uniquely positioned for coastal, wetland, and global conservation of these plants. The eight greenhouses holding the collections were built in the 1970s and are in need of replacement. Hurricane Ian's catastrophic winds destroyed one of these greenhouses as well as some of the plants inside. In order to prevent future damage to this collection so critical to the world of science, we must begin the planning for a greenhouse complex that is resilient to hurricanes that are expected to become stronger and more frequent in the years to come.
