The Legislature has previously funded a comprehensive study of this area. The City of Panama City seeks to implement these recommendations through design work of our stormwater system, land acquisition, construction, and dredging.

b. What activities and services will be provided to meet the intended purpose of these funds?

Construction of enhanced stormwater facilities to include retention and stormwater detention ponds, conveyance ditches, and culverts, to provide greater capacity and more efficient conveyance of stormwater to prevent vulnerable areas from continued flooding rain events.

c. What direct services will be provided to citizens by the appropriation project?

The enhanced capability of the City's Southern stormwater system would result in better conveyance of stormwater during heavy rainfall events. Additionally, this project would increase safety of the traveling public and assist in preventing flooding of private property which results in preservation and potential increase of property values for citizens.

d. Who is the target population served by this project? How many individuals are expected to be served?

General population. Greater than 800.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Protection of St. Andrews Bay, wildlife habitat, and fisheries through reduction of contamination, turbidity, and higher quality stormwater discharge. Measurement of accumulation of sediment in bay savers, turbidity measurements at stormwater outfalls, and fewer occasions where our system is overwhelmed in the project area.
