Total reconstruction of the intersecting no outlet roadways on north and south side of SW 27 Street from SW 27th Court to SW 31st Place, including storm water drainage improvements, new and safer ADA compliant sidewalk and crosswalks. Partnering with Miami-Dade County Water and Sewer Department, water main upgrades will be included as a component. The streets will also be widened to reduce potential vehicular traffic and pedestrian safety conflicts/hazards in the existing very narrow streets. This project will increase flood protection and provide safe routes to schools and parks for area residents.
