1. Project Title Bal Harbour Village Jetty Elevation and Resiliency Project

#### 4. Project/Program Description

Over the years Bal Harbour Village, Army Corps of Engineers, the Florida Department of Environmental Protection and Miami-Dade County have conducted numerous studies of the area encompassing Bakers Haulover Inlet, which is where the southside Jetty is located. This Jetty has been in existence for over 100 years and after decades of withstanding storm surge conditions is in critical need of restoration. The project proposes increasing the elevation of the Jetty, reinforcing its seawall and overwater structures, which will adapt the Jetty to hazardous conditions and make the Cutwalk above the Jetty ADA accessible and compliant. Currently, there are days when the Jetty is unwalkable due to the raging waves overcoming the structure. By adapting the structure and increasing its storm-resilience we can help mitigate against the risks posed by storm related damage. The Jetty is about .85 of a mile and is one of two jetties in Bakers Haulover Inlet. It is a critical asset of the area.

#### 14. Program Performance



#### a. What specific purpose or goal will be achieved by the funds requested?

The Jetty at Bakers Haulover Inlet has been in existence for over 100 years and after decades of withstanding storm surge conditions is in critical need of restoration. It requires that the Village elevate the Jetty height and reconstruct the existing seawall along the inlet. The Jetty protects the upland properties from harsh wave intrusion that leads to flooding. Near the Jetty are numerous high-rises that depend on the Jetty barrier for protection against the Atlantic Ocean. The current condition of the Jetty leaves the public at risk of injury and improvements to the Jetty will mitigate against that as well.

#### b. What activities and services will be provided to meet the intended purpose of these funds?

Although direct services will not be provided to citizens through this project we do believe that residents and tourists will gain a greater appreciation for the natural environment by bringing them closer to the marine life, giving them an engaging outdoor experience. In addition, the walking path along the Jetty will be improved and made ADA compliant.

#### c. What direct services will be provided to citizens by the appropriation project?

In the future, we would like to host environmental guest speakers at the Jetty to give talks to the public on the importance of valuing and respecting our natural environment and our beautiful ocean. These events will be made possible through a safe and walkable Jetty that is accessible to people of all abilities.

#### d. Who is the target population served by this project? How many individuals are expected to be served?

The target population is general as the majority of funds will benefit no specific group. The project will reach over 800 people. Bal Harbour Village serves over 3,000 residents. However, it is important to note that the project will also include handrails with Braille to describe the sites for the enjoyment of the blind.

# e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

The Jetty project will enrich cultural experience for the community and protect the public as well as upland properties from harm/damage. Hence, the project will include over water platforms to connect people of all abilities with nature and ensure equitable access to all. In addition, the Jetty will be elevated and necessary safety enhancements will be added such as lighting, guardrails, and an ADA compliant cutwalk to ensure the safety of pedestrians using the Jetty. Outcomes will be measured through the contractor's compliance with design requirements and any injury reports collected post-completion.
