This will compliment the Wastewater treatment plant that is already under construction. A water plant at the NFMIP will provide future tenants of the North Florida Mega Industrial Park potable water for industrial warehousing, and manufacturing job along with workforce housing and commercial businesses. The NFMIP is one of Florida catalysts site as designated by the FL Department of Economic Opportunity. Columbia County received \$2,000,000 in CARES Act Funding that was allocated towards the NFMIP WWTP to shore up an existing grant. \$13.9 million of ARPA money was divided up as follows: \$6.2 million for Fort White water projects,\$4 million for the NFMIP WWTP, 1.7 million in business assistance, 679k for individual assistance, and \$1 million for emergency home repair. An additional \$729,853 came from the LCTPA portion of funding that is uncommitted.
