Two sets of Aeration Panels must be replaced at the WWTP to address permit and maintain proper wastewater treatment requirements that allows the plant to treat 220,000 gpd of wastewater to tertiary levels which is discharged to the treatment plants man-made wetlands disposal site. The project is located in the Caloosahatchee River Estuary and Basin and Lake Okeechobee Estuary. Glades County is a financially disadvantaged community that is designated as a Rural Area of Economic Concern.



Expected benefit is improved wastewater management with the replacement of the two aeration panels and protection of life, health, safety and the environment; addresses FDEP permit WWTP capacity/water quality/quantity rules and regulations; the aeration equipment allows the plant to treat 220,000 gpd of wastewater to tertiary levels which is discharged to the treatment plants man made wetlands disposal site.
