The purpose of this project is to provide a place for community engagement through community events held in common space and performing arts auditorium, provide central office space for school district services, and provide a location to learn about Jackson County history. Currently, ESE, Curriculum, and MIS services are in separate locations. This will provide parents and the community a single point of location for school services and a location for events to strengthen community bonds.

b. What activities and services will be provided to meet the intended purpose of these funds?

Renovate previous high school building to pull together services into one location for parents and community. Provide access to the community to old cultural events and view history of Jackson County.

c. What direct services will be provided to citizens by the appropriation project?

Improved student achievement and outcomes to 6,000 students and their families. Provide access to community services that benefit families of students and the community through cultural/community events in the auditorium and museum section of the renovation. Renovated auditorium will be available for community events benefitting the region's 65,000+citizens.

d. Who is the target population served by this project? How many individuals are expected to be served?

Pre school students, grade school students, high school students, university and college students, at-risk youth, economically-disadvantaged persons, developmentally disabled, physically disabled, elderly persons. At least the area's 6,000 students and their families. The larger regional population of 65,000+ citizens.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

be measured?

Improved quality of education due to the centralized availability of services such as ESE, curriculum and other services. Outcomes measured by district grade. Enriched cultural experiences due to the auditorium and museum section as measured by the number and frequency of community events integrating students and Jackson families and community members. Increased and improved economic activity due to the auditorium and museum as measured by visitors drawn to the site. Increased tourism due to the museum as measured by the volume of visitors. Estimated 36 full-time equivalent jobs with economic impact of \$2.5 million during construction.
