4. Project/Program Description

K9s United is a non-profit organization based in Jacksonville. It was founded by Debbie Johnson in 2015 following the tragic death of Baron, a St. Johns County K-9 Officer. K9s United supports Law Enforcement K-9 units throughout the state by providing much needed equipment and training when there are budget shortfalls within the individual agencies. When a request is made, K9s United goes directly to the vendor to negotiate a discount, purchases the item and donates the equipment directly to the agency. K9s United also provides life-saving first aid training to K-9 handlers and EMS personnel to increase the chance of survival when a K-9 is injured while protecting Florida communities. Additionally, K9s United provides multi-day advanced training seminars for K-9 teams across the state.

b. What activities and services will be provided to meet the intended purpose of these funds?

K9s United helps fill budget voids and aid law enforcement agencies to ensure K-9 units have the programs and supplies the dogs and their handlers need most. Specifically, these funds will be used to provide essential equipment, such as bulletproof vests, canine medical kits, vehicle heat alarms and door poppers, and vehicle kennels. The monies will also fund life-saving first aid seminars for K-9 handlers and EMS personnel (topics include: combat injuries, hemorrhage control, airway management, wound management, snake bites, bloat, and other life saving techniques that may be required in an emergency situation.) Additionally, funds will allow us to provide advanced, customized training, such as problem solving, human detection, tracking, building searches, odor and narcotics/explosives detection, criminal apprehension techniques, and scenario-based training.

c. What direct services will be provided to citizens by the appropriation project?

The citizens of Florida are the ultimate beneficiaries of the equipment and additional training provided by K9s United. These K-9 units help get deadly drugs off the streets in Florida communities all over the state of Florida. They find lost children and elderly adults and these K-9 teams put themselves in danger day in and day out as they protect and serve Florida's citizens.

d. Who is the target population served by this project? How many individuals are expected to be served?

There are hundreds of K-9 units across the state of Florida. K9s United wants to be a resource for any local law enforcement agency that is experiencing budget shortfalls and needs assistance equipping their K-9 units with the life saving equipment and training required to protect and serve our communities at the highest level.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

As a recipient of these funds, K9s United will be able to grow as an advocate for Florida's Law Enforcement K-9s, by providing them with essential equipment, and giving their handlers additional training to help them in their job of protecting and serving the citizens of Florida. As a measurement of success, K9s United is (and will continue to be) in regular contact with the K-9 agencies that we work with to ensure that we are providing the exact resources and support they need.
