

1. Project Title Dania Beach SW 52nd Street Stormwater Improvement Project

4. Project/Program Description

SW 52nd Street is a low-lying road within the western limits of Dania Beach, consisting primarily of single-family homes that flood because there is no stormwater infrastructure. A study was conducted to recommend stormwater improvements to alleviate flooding. Phase I improvements are currently being constructed along SW 43 Terrace that discharge stormwater to a nearby lake. The SW 52nd Street project is the next phase to build infrastructure along SW 52nd Street, connecting to Phase I improvements.

Improvements include the installation of drainage pipes and inlets and regrading swales along 2,000 linear feet of SW 52nd Street, from S.R. 7 east to SW 40th Avenue. The project is 100% designed and has all the required permits. The cost estimate for this project is \$1,000,000. Therefore, the City requests \$500,000 in funding and will provide a \$500,000 cash match for the project.

Additionally, the City received an allocation of \$16.2 million through /SLFRF, and expended \$10 million in revenue replacement funds toward public safety payroll expenditures, and the remainder is being programmed

The purpose of this project is to lessen the flooding the on SW 52nd Street. Less flooding will result in better water quality. The project will move stormwater from SW 52nd Street to an adjacent lake, through adjacent swales and improvement stormwater infrastrucure. The other purpose is to make the neighborhood more resilient to flooding and sea-level rise.

Construction activities by a third party contractor.

Flooding relief by decreasing the duration of flood waters that block access to emergency response to residents. Decrease the likelihood of damage to homes and property by flood water.

The target population of this project is the residents of "Playland Estates", located in Census Track 803.03, Block Group 3. This area is made up of 70.26% Low and Moderate Income persons. The population is 1,345.

The expected outcome is less flooding and decreased duration of flooding. Visual inspection of the street after rain events.

The suggested penalty would be a reimbursement to the state for state funds.
