#### b. What activities and services will be provided to meet the intended purpose of these funds?

The 14,000 sq. ft. of additional space will accommodate 6 new galleries/educational art spaces that will allow for display of a growing collection on a permanent, rotating basis, supporting the mission of becoming a destination art museum, meeting the cultural and educational needs of the community as its art museum, and attracting an increasing number of visitors and tourists to the region.

#### c. What direct services will be provided to citizens by the appropriation project?

PMoA is the only Smithsonian-affiliate fine art museum in Central Florida; it is also, importantly, admission-free, providing visitors with incomparable, no-cost opportunities to experience art in fun and educational ways. The expansion enables the museum to host more exhibitions of history's most acclaimed artists, offer more exceptional free programs, and elevate the museum's national and international profile.

#### d. Who is the target population served by this project? How many individuals are expected to be served?

PMoA serves a wide population of visitors and learners of all ages and abilities (including general audiences, preschoolers, K-12 students, college students, at-risk youth, and the elderly) from diverse populations throughout Polk County and neighboring regions as well as from across the state, the country, and the globe. With the expansion and increased national and international recognition, the museum hopes to welcome a host of new, ever more diverse audiences to the county, the region, and the state, while maintaining dedication to the visitors and students served at present. With the expansion, PMoA expects to serve between 60,000 and 70,000 annual visitors in the first year following completion of the project.

# e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

PMoA expects the project, once completed, will yield: (1) increased number of masterwork and permanent collection exhibitions annually; (2) increase in the annual number of in-county residents of all ages visiting the museum; (3) increase in the annual number of out-of-county patrons visiting the museum; (4) increase in the annual number of in-county overnight stays by museum visitors; (5) increase in the annual number of memberships. PMoA will measure the progress toward these goals by: (1) tracking the number of masterwork and permanent collection exhibitions annually and maintaining a database of these exhibitions for annual comparison of exhibition numbers; (2) requiring visitors to obtain a sticker at entry desk before touring and tracking stickers distributed daily; and (3) ask patrons and new members for their zip code and state or country of origin and to complete a survey.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for the contract?

If the project doesn't proceed, the Museum (PMoA) will return the funds to the state.
