### 4. Project/Program Description

The Historic Butler House 1923, listed in the National Register of Historic Places, is one of the last few remaining structures that belonged to one of Deerfield's most prominent and recognizable pioneer families. It was bequeathed to the Deerfield Beach Historical Society in 1977 with furnishings and period relics. The house is a hub for community activities, open to visitors, and its resource library protects and provides valuable archives for public research and viewing purposes. Full extent of damage and deterioration over the years was identified in a 2021 Historic Structures Report and Conditions Assessment by RJ Heisenbottle Architects. Support through the Local Funding Initiative will enable restoration to its original construction, architectural, structural, mechanical, electrical and plumbing systems repair, and improved ADA accessibility.

### 14. Program Performance

### a. What specific purpose or goal will be achieved by the funds requested?

The rehabilitation will restore the historic integrity of the building as an anchor of the historic district, a house museum, and public office for the Deerfield Beach Historical Society. Upgrades will improve operation as a reference library for documents, pictures, and maps of historical significance to Deerfield Beach and Broward County. Access for those with physical challenges will meet ADA compliances.

### b. What activities and services will be provided to meet the intended purpose of these funds?

Immediate services by the Historical Society to meet the primary goal of the rehabilitation will be provided through the collaborative efforts of the Directors to utilize their business networks which include expertise in historic restorations, archival preservation, and lighting systems. These efforts will be guided by the Architectural firm of R.J. Heisenbottle who conducted the third party assessment and recommendations report contracted by the organization. Subsequently, the public profile will strengthen as an anchor for the revitalization of the "old" downtown area, media coverage and on-site signage will encourage civic participation, acknowledge support, and expand knowledge of the organization's activities and community services.

### c. What direct services will be provided to citizens by the appropriation project?

Direct services include public and school tours, educational programming through recurring events, concerts and lectures, and accessibility to a resource library for research and archival preservation. In addition, the Historic Butler House and grounds will be available to civic and cultural organizations as well as private citizens for meetings, concerts, and family occasions. Free services include admission to Homestead Day tours, book signings, lectures, Memorial Day Commemoration, Smithsonian Museum Day, Black History Month Exhibitions, and Women in History Month. Accessibility enhancements will open the experience inclusively. Youth are offered community service opportunities and hours as a member of the Junior Historical Society.

### d. Who is the target population served by this project? How many individuals are expected to be served?

Deerfield Beach records a population of almost 79,500 as of July 2019. 6,900 are enrolled students 18 years of age and under, 21% or 16,600 are senior citizens. Almost half or 47% of the population of Deerfield Beach is considered as minority. The 33441 zip code covers a major portion of the local population. The Intracoastal Waterway divides beachfront residents from the city proper. Specific audiences that the Deerfield Beach Historical Society seeks to build through increased public awareness of its historic stature and activities include "beach front" residents, families, seniors, and minority populations. Statewide, the organization will promote participation with destination events, "Hang Your Hat on Heritage Tourism". The current annual visitation is estimated at 12,350 people based on 10% of the population, 690 students and 3,600 tourists.

## e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

#### be measured?

It is anticipated that the restoration will enrich the cultural experience, improve the quality of education, support a healthy business climate, motivate visitation and create immediate job opportunities. Enriching the experience includes showcasing the Historic Butler House restored to its original construction as an authentic tour talking point, available for inclusive exploration. The quality of education is improved visually and accurately. Archives are protected for generations to come. Businesses are supported by new audiences becoming customers in an active cultural sector and the compensations of presenting historic and cultural programs by the Historical Society. The rehabilitation will employ 42 craftsman, professional experts, and materials suppliers. Evaluation methods include activity registrations, event evaluation forms, participant reactions including social media comments, and feedback from tourist industries. The Project Manager records job opportunities.
