The James B. Sanderlin Family Service Center, Incorporated, a neighborhood family center, has provided services to the community for 31 years. The Center's mission is to cultivate a community where children and families are valued, loved, and destined to succeed. The requested funds will be used to hire an architect and engineer to design a 10,000 square foot education building and a 9,000 square foot social service building. We have invested over 1,000,000 in repair and maintenance costs over the past five years in the current building.

The requested funds will be used to secure an architect and engineer to design an education and social service building that is shovel ready. The Center is located at 2335 22nd Avenue South, St. Petersburg, FL 33712.

The James B. Sanderlin Family Service Center will continue to provide aftercare, spring break, and summer camp services to children ages 6 - 14 in a safe modern building. The Center will also continue to provide family support services to families in a safe, modern building.

d. Who is the target population served by this project? How many individuals are expected to be served?

The target population for aftercare, spring break, and summer camp services are children 6 - 14 years of age. Family support services are open to all citizens of Pinellas County; however, we generally service families who live in the following zip codes: 33701, 33703, 33704, 33705, 33711, 33712, 33713.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

be measured?

The expected benefit of the project is a safe building that meets coding requirements for the department of health and the city of St. Petersburg. The project will also decrease the repair and maintenance costs currently being used to maintain the building. The methodology will be measured by the Center's ability to obtain a cleared certificate of occupancy from the city of St. Petersburg and a childcare license through Pinellas County's Department of Health.
