4. Project/Program Description

Following the catastrophic Hurricane Ian wind and flood damage, this funding will be used to restore and repair the over 100,000 sq. ft. Historic Arcade Theatre and surrounding Florida Rep campus including: education classrooms, ArtStage Theatre, costume/scene shop, rehearsal hall/backstage, box office, employee housing, and offices to original capacity to ensure Florida Rep remains a cultural anchor to downtown Fort Myers. The total cost for emergency remediation, repairs, and replacement of equipment is anticipated to exceed \$2,750,000.

a. What specific purpose or goal will be achieved by the funds requested?

Following the catastrophic Hurricane Ian wind and flood damage, this funding will be used to restore and repair the over 100,000 sq. ft. b. What activities and services will be provided to meet the intended purpose of these funds?

For over 25 years, Florida Rep has been an anchor to the downtown arts community supporting local area businesses. Funds will be used to repair and restore the Florida Rep campuses in order to be able to provide educational and theatre programs that make the arts accessible to every segment of the community and ensure that Florida Rep remains an area attraction for downtown Fort Myers.

c. What direct services will be provided to citizens by the appropriation project?

In addition to ticketed productions, programming provided to the community include the Theatre for Young Audience Series, Camp Florida Rep, Conservatory Productions, classes for youth and adults, an in-school residency programming, need-based student scholarships, discounted student tickets, volunteer opportunities, Blue Star Theatre program for military and veterans, and accessible performances.

d. Who is the target population served by this project? How many individuals are expected to be served?

Florida Repertory Theatre serves over 100,000 patrons each year through 5 main stage and 4 ArtStage productions. FL Rep participates in various community activities to promote the theatre and encourage attendance including speaking engagements, festivals, and community outreach. Florida Rep's Education programs reach young people and families through The Theatre for Young Audience Series (TYA), Camp Florida Rep, Conservatory Productions, Youth Classes, and an In-School Residency. The primary focus for TYA program includes the under-served populations and schools.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

be measured?

Funds will be used to repair and restore the Florida Rep campuses to provide educational and theatre programs that make the arts accessible and ensure that Florida Rep remains an area attraction for downtown Fort Myers. In addition to point of sale transactions, FL Rep will also track "Stay and Play" sales and tour attendance. FL Rep will continue to market to the 5 county region and partner with VCB to target patrons through nation-wide advertising. FL Rep will use Arts & Economic Prosperity survey data to measure the outcome.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for the contract?

Should Florida Repertory Company, Inc., fail to meet the deliverables or performance measures, it will not accept the funding and/or the appropriation will be returned to the state.
