Construction of Mercy Village to establish 65 units that will house our family and student self-sufficiency program clients. The 5.1 acre property and 7,000 sq. ft. building was purchased by donations of \$1.125 M The Village will allow us to expand our capacity for programs and services to meet the growing needs of families and students in Clay County The Village will have 1-, 2- and 3- bedroom apartments for our adult and family self-sufficiency clients, as well as 2 dorm-style apartments for unaccompanied 18-year old high school students referred to us by Project Reach coordinators. Mercy Support Services has cultivated a robust program to meet the needs of people in crisis for the last 12 years by providing a safe place of hope, potential and possibilities to break the cycle of poverty. Our successful programs achieved true transformation for those whose circumstances have placed them in heed. Our programs result in less dependence on subsidies and other government support.

Mercy Village will provide stable housing for adult, family and student clients. The goal of our programs is to empower people to use their own skills and abilities to care for themselves and their families. Successful graduation will mean a client is able to secure adequate housing, maintain a permanent full-time job with adequate pay, have discretionary income and the ability to save, has reliable transportation, no or extremely low reliance on government benefits and is spiritually and mentally sound.

#### b. What activities and services will be provided to meet the intended purpose of these funds?

Families and students will be housed and offered a self-sufficiency program that will provide an individualized Care Plan based on the barriers that have kept them in the situation they are. The housing costs will be set at 30% of their income when an income is being earned.

#### c. What direct services will be provided to citizens by the appropriation project?

In order to prepare individuals to be able to provide for themselves and their families the Care Plan will include but not limited to: life and financial coaching, life skills training, career development to include an educational component. Preparing parents for independent living at the same time influencing outcomes for their children as well.

#### d. Who is the target population served by this project? How many individuals are expected to be served?

According to the US Census Bureau 9.6% of Clay citizens live at or below the federal poverty level and 37% live below the United Way ALICE level. Mercy Village will expand our current capacity to serve those in Clay County who circumstances place them in temporary need. 92% of our clients are woman who are divorced, separated or abandoned, most with children. The 63 1-, 2-, and 3-bedroom apartments will be able to serve an average of 180 adults and children depending on family size and 8 unaccompanied high school students, 4 males and 4 females.

# e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

### be measured?

The expected benefits will be families that are more prepared to face the challenges of living. Our Self-Sufficiency program is focused on life transformation. It is one thing to teach a person how to make a living, we also need to teach them how to live. Their will be an activity center on the campus to foster community activities and interaction with their neighbors. The center will be the hub for tutoring, cooking classes, shopping on a budget as well as game nights, movie nights, etc.

Outcomes will be measured by graduation rates, increase in income levels, sustainable employment, improvement in education. We will also encourage families to give back financially and trough volunteering. We are able to trach client's progress software called Mission Tracker.
