#### 13. Program Performance

### a. What specific purpose or goal will be achieved by the funds requested?

The purpose of this project is to improve sandbag production efficiency for public distribution of sandbags prior to an impending tropical storm or other flooding event.

#### b. What activities and services will be provided to meet the intended purpose of these funds?

This funding will be utilized to purchase a mechanized sandbag filler, which will be used to fill sandbags for residents and businesses prior to a storm or flooding event. The mechanized sandbag filler can produce 1,200 sandbags per hour.

#### c. What direct services will be provided to citizens by the appropriation project?



This mechanized sandbag filler project will result in the efficient production and distribution of sandbags to residents and businesses prior to a tropical storm or other flooding event, protecting life and property.

#### d. Who is the target population served by this project? How many individuals are expected to be served?

The residents and businesses in Daytona Beach Shores will be positively impacted by this project. The number of individuals expected to be served includes the residential population of approximately 5,200 along with an additional 5,000 to 10,000 visitors.

### e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

This mechanized sandbag filler project will increase sandbag production efficiency and total sandbags distributed, which could result in reduced flooding impacts and increased protection of residences and businesses during a tropical storm or other flooding event. The outcome will be measured by the purchase of the mechanized sandbag filler and the number of sandbags filled during each event.
