The Parent Aide program is an initiative of the National Exchange Club, an evidence-based, in-home prevention services program, providing 6-12 months of services to families with children of all ages. Parent Aide will provide weekly services to 265 families/approximately 620 children in Duval, Clay, Baker, Nassau and St. Johns counties. The goal of the program is to assist parents learn the skills necessary to provide a safe, stable and nurturing environment for their children and reduce the likelihood of DCF intervention thereby keeping children out of the foster care system. We are the only evidence-based program of this type serving NE Florida's families with children of all ages. Outcomes from past years indicate that over 99% of the parents who graduate from the Parent Aide program will have no confirmed report of child abuse or neglect within 12 months of graduation, and no child has been removed by DCF whose parent completed this program over the past 6 years of state funding.

13. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

Parent Aide will serve 265 families referred by DCF investigators, CBC prevention services case managers, public schools, and a wide variety of local social services agencies. Any family with a child under the age of 18 is eligible. Our goal is to help parents learn the skills necessary to create a safe, healthy and nurturing home environment and to deter further intervention from DCF or law enforcement, keeping families together and out of the foster care system. The program and curriculum focuses on building protective factors and parental resilience. In FY24, 71% of families enrolled had children over the age of 5 years, making them ineligible for other in-home programs, and 80% were from DCF investigators and lead agency prevention services case managers for low-to-moderate risk families who had been referred to the Abuse Registry. Public schools also refer families with young children who are chronically absent, to help parents overcome obstacles to attendance.

b. What activities and services will be provided to meet the intended purpose of these funds?

Parent Aide services will be provided to every family who voluntarily enrolls in the program. An Initial Needs Assessment (INA) is completed with each parent and a Family Plan is developed based on the unique needs of each family. The Plan includes goals developed by the parents to be completed during enrollment, and curriculum to be covered based on the INA. All services are provided in the home with weekly 60-minute visits for 3 months and bi-weekly for an additional 3 - 9 months. Pre and post-assessments measure the parents' progress on five specific constructs of parenting, and pre and post-Protective Factor Surveys are completed by parents which demonstrate the parents' improvement in ability to meet their child's needs and build resilience to parenting challenges. Throughout the enrollment period, each child is also provided age-appropriate books monthly and the need for regular school attendance is strongly encouraged. Additional referrals are made as needs are Identified.

c. What direct services will be provided to citizens by the appropriation project?

All parents will be provided with 18-24 hours of evidence-based curriculum, delivered in the family's home over a 6-12 month period. We may provide help with basic needs which parents often cannot afford, through referrals to Hope Florida, guidance for job seeking adults, and referrals to other local community resources as needs are identified, such as therapy or substance misuse treatment. Housing assistance and referrals are also provided for families who are homeless or at risk of becoming homeless, and we may assist with rent or utility bills if funding is available. Our goal is to help stabilize families, provide parenting guidance and keep children safely at home and out of the foster care system whenever possible. Over 99% of our parent graduates have no confirmed case of abuse or neglect within 12 months of graduation, and no child has been removed by DCF after the parent completed the program over the past six years, when state funding was first appropriated for program.

d. Who is the target population served by this project? How many individuals are expected to be served?

We will serve 265 families/approx 620 children. Referrals come from DCF and lead agency prevention case managers for children deemed at low-to-moderate risk of abuse/neglect, and who therefore do not qualify for high-risk services provided by the lead agencies. We also accept referrals for families who do not qualify for other in-home services programs funded by the state or federal government due to the age of the child. Other in-home programs (Healthy Families, Healthy Start, Nurse to Family Partnership) focus on 0-3 years; 71% of our families in FY24 had children over age 5 years. We also accept referrals from the public schools for families with children under 12 who are chronically absent, to help parents overcome obstacles to the child's school attendance.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Children will remain safe and healthy in their own home with parents who have the skills and ability to provide a safe and nurturing environment, thereby preventing intervention by DCF and possible out-of-home placement for the children. Parent Aide is a nationally accredited program of the National Exchange Club and has been deemed as a Promising program of High Relevance for Child Welfare by the CEB Clearinghouse for Child Welfare (https://www.cebc4cw.org/program/exchange-parent-aide/). The Parent Aide goals are: Assure Child Safety, Improve Parenting Skills, Improve Problem Solving Skills and Enhance Social Supports. Using the Nurturing Parenting Program pre and post AAPI assessments, and Protective Factor Surveys, parents will show an improvement in at least two parenting constructs (AAPI) and Protective and Resiliency factors.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for in the contract?

With each DCF contract, we could incur a possible financial penalty for any performance measure we do not meet. All performance measures and deliverables are reported monthly to DCF, and a 'Return on Investment' form is completed quarterly and annually. Parent Aide consistently costs just under \$1,600 per child annually, as opposed to the \$105,131 per child cost estimated in the 'Child and Family Services Plan 2020-2024' issued by DCF in their report to the federal government.
