a. What specific purpose or goal will be achieved by the funds requested?

The funding will enhance animal well-being and staff safety. Funding will be used to reduce stormwater runoff, restore wetlands, and supporting natural resource stewardship. It will also improve safety for 400,000 visitors, 100+ staff, and 500+ animals through a mass notification system, access controls, security cameras, lighting, fencing, and a fiberoptic network for enhanced monitoring and communication.

b. What activities and services will be provided to meet the intended purpose of these funds?



The funding will enhance security systems to ensure a safe experience for guests, staff, and animals, while enabling the Zoo to continue serving the communities of Palm Beach, Broward, Martin, and St. Lucie with educational programs, recreational activities, and tourism opportunities.

c. What direct services will be provided to citizens by the appropriation project?

The funding will be used to enhance the safety and security of both visitors and staff at the zoo, as well as to support the ongoing operation of the zoo.

d. Who is the target population served by this project? How many individuals are expected to be served?

Visitors of the Palm Beach Zoo, 400,000.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Enhanced security measures, including real-time monitoring, digital access controls, and automated gates, will ensure the safety of guests, staff, and animals. Improved communication systems will address safety concerns like severe weather. Water quality improvements in Baker Lake and stormwater runoff will reduce phosphorus and bacteria, increase dissolved oxygen, and support healthier aquatic life. These efforts will improve safety, reduce injuries, and promote a sustainable, healthy environment for both zoo animals and visitors.
