a. What specific purpose or goal will be achieved by the funds requested?



The proposed regional training center will provide specialized training programs in critical areas including de-escalation training, human trafficking, highly addictive and lethal narcotics and scenario-based skill development. Furthermore, it will have far-reaching benefits, including enhanced public safety through better prepared officers; Improved community trust by ensuring officers are trained to employ fair and equitable practices; and through the adoption of best practices through continuous professional development.

#### b. What activities and services will be provided to meet the intended purpose of these funds?

Beyond officer advanced training and professional development, the center will serve as a platform for collaboration with state and federal agencies, fostering the exchange of information, insights, and innovative techniques. This advanced approach will improve multi-agency coordination and response capabilities to address a wide range of public safety concerns. The Regional Training Center represents a proactive step in ensuring that our law enforcement professionals are well-prepared to serve and protect their communities with integrity and excellence.

#### c. What direct services will be provided to citizens by the appropriation project?

The Brevard County Sheriff's Office is committed to fostering transparency, safety and community engagement through the establishment of the new law enforcement training center. The center will directly benefit the citizens by enhancing public safety through advanced training as well as community engagement opportunities by hosting regular citizen workshops and open house events. Citizens will have access to public tours and informational sessions that provide insight into law enforcement training methods. Furthermore, the center will offer educational initiatives for youth and community members interested in pursuing careers in law enforcement.

#### d. Who is the target population served by this project? How many individuals are expected to be served?

The proposed law enforcement training center will serve the residents of Brevard County, a vibrant and growing community with a population of 643,979. In addition to its permanent residents, Brevard County welcomes over 2.5 million tourists annually, underscoring the need for a highly trained and prepared law enforcement presence to ensure public safety for both residents and visitors to include the Space Center and Port Canaveral.

The law enforcement training center will also extend its services to neighboring counties, including Volusia, Orange, Seminole, Osceola and Indian River, fostering regional collaboration and providing standardized, advanced training for law enforcement agencies across Central Florida. By addressing the unique needs of both the local population and the broader region, the training center will play a pivotal role in enhancing public safety, strengthening community trust, and promoting professional development for officers.

By investing in cutting-edge advanced training and prioritizing the well-being of both officers and the public, the Regional Law Enforcement Training Center aims to create safer neighborhoods, improve community relationships, and build a stronger foundation of trust and accountability. The success and impact of the new training center will be measured through a combination of qualitative and quantitative metrics to include- reduction in use of force incidents, community feedback and trust surveys, officer performance metrics, crisis response outcomes, crime and safety statistics, community participation in engagement programs, and retention and recruitment rates. By setting clear benchmarks and regularly reviewing these metrics, the center will ensure accountability and demonstrate its effectiveness in achieving its intended goals.
