#### 4. Project/Program Description

For some time now, Florida has had a youth mental health crisis and concurrent critical shortage of child mental health professionals. Since 1999, the Center for Child Counseling (CFCC) has been a community nonprofit at the forefront of these issues, fighting the horrible impacts of trauma, abuse, and violence inflicted on children. Last year, CFCC served over 7500 disadvantaged children and families in Palm Beach County alone, partnering with public and private local stakeholders, yet referrals to CFCC have continued to increase. In 2023, CFCC received a state appropriation to expand its own capacity and eliminate the waitlist of 500-1000 families waiting for services from CFCC. Now, if funded, this 2025 appropriation (with federal and local government matching funds) will allow CFCC to contribute to the pipeline of qualified child mental health professionals across Florida by expanding CFCC's capacity to train hundreds of therapists (new and existing) for other providers statewide.

#### 13. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?



For some time now, Florida has had a youth mental health crisis and concurrent critical shortage of child mental health professionals. The data is alarming: 47.4% of Florida middle/high school students have reported they felt depressed on most days; and 12.3% had at least one major depressive episode during the last 12 months, but of those, 61.8% did not receive ANY mental health services. Meanwhile, in 2023, the ratio of clients to mental health professionals in Florida was a totally unacceptable 550/1. This is an urgent and immediate need statewide. Funds will be used to provide in-field and web-based training for 750+ qualified mental health practitioners and program specialists annually to contribute to the statewide pipeline of skilled master and bachelor's level behavioral health professionals, especially with respect to the availability of services for disadvantaged and foster care children.

#### b. What activities and services will be provided to meet the intended purpose of these funds?

New bachelor level and master's level behavioral health professionals will participate in the in-person and web-based training programs, curriculum, and supervision. CFCC utilizes an innovative training approach, which provides a combination of site-based and web-based training to CFCC student interns and new clinical staff. Phase 1 of the curriculum promotes the integration of theory and practice among staff and situates their perspective within the context of CFCC's client populations. Phase 2 focuses on honing the skills of more experienced therapists as they grow as experts in their field.

#### c. What direct services will be provided to citizens by the appropriation project?

Ultimately, CFCC expects the program to contribute to the statewide pipeline of available and well-trained bachelor and master's level youth mental health professionals, who are then able to serve thousands of children in need across Florida, many of whom have been victimized by adverse childhood experiences like trauma, abuse, and violence. The program will provide in person (and web-based) training and supervision for hundreds of new therapists and student interns, which will, in turn, increase the statewide workforce pipeline of competent and skilled behavioral health professionals. Thousands of children in need will see positive mental health outcomes.

#### d. Who is the target population served by this project? How many individuals are expected to be served?

Thousands of children and families across Florida will be served and benefited by this project. The project will also serve and benefit hundreds of incoming and existing professionals in the behavioral health field. CFCC has a long history working in the community (since 1999) and is well supported, with numerous letters of recommendation from local elected officials and community organizations/partners on both sides of the partisan divide. CFCC is also currently partnering (including funding) with Palm Beach County and the Palm Beach County School District to provide urgently needed mental health services and counseling to children and families who experienced trauma. This project will export that capacity across Florida by providing in-person and web-based training to 750+ new mental health professionals annually.

#### e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

#### be measured?

The mental health and resilience of our children is vital for Florida's future. With an estimated 1 in 4 children in Florida experiencing an adverse mental health issue, we must re-imagine our approach to care and greatly expand the pipeline of qualified professionals to provide services. CFCC's public health framework has, for years, been focused on building caregiver and community capacity to support children's mental health. CFCC's Data Dashboard will be used to track all training outcomes, at the child, family, staff, and community levels. Through a collaboration and data sharing agreement with Florida State University, this model will be analyzed, with publication of results to inform practice in other communities.
