#### **13. Program Performance**

#### a. What specific purpose or goal will be achieved by the funds requested?

It is the goal of this program to contribute to Florida's efforts to reduce opioid misuse behaviors and opioid-related mortality and morbidity through targeted professional training and community-based educational interventions.

#### b. What activities and services will be provided to meet the intended purpose of these funds?

- Train primary care & other health professionals to prevent/manage/reduce opioid misuse in high-risk populations including youth, the elderly, veterans, the homeless, and individuals with behavioral health needs.

- Enhance opioid misuse curriculum of health professions students and residents in training

- Promote evidence-based opioid misuse screening & intervention strategies at health care, social service, school clinics, faith-based organizations, and other targeted sites with limited/non-existent resources

- Provide educational programming focusing on increasing awareness of fentanyl exposure risk in urban and rural communities impacted by opioid misuse.

#### c. What direct services will be provided to citizens by the appropriation project?

-Health professionals and health professions students will be more informed about evidence-based opioid misuse identification, treatment and prevention.

-Social workers, educators, peer counselors, school counselors, community health workers, caregivers, and other service providers will be trained and equipped to detect, intervene with, and refer to services individuals with real or potential risk of opioid misuse

#### d. Who is the target population served by this project? How many individuals are expected to be served?

Persons with poor mental and/or physical health, physically disable persons, drug users, economically disadvantaged individuals, at-risk youth, LGBTQIA, elderly, grade school students, high school students, college students, jobless persons, and homeless persons. It is estimated that 500 health professionals and 1,100 health professions students from multiple disciplines and 4,000 individuals in rural and urban communities impacted by opioid misuse statewide will be served.

#### e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

#### be measured?

AHEC will: 1) Provide systems-based support to at least 25 primary care sites and 25 community-based organizations around the state - particularly in rural and medically underserved communities - to enhance pain management services, reduce the risk of opioid misuse, and identify and treat opioid misuse. AHEC will track systems enhancements at targeted primary care delivery sites and community based organizations. The State will be able to assess increases in treatment outcomes and reductions in opioid misuse morbidity and mortality. 2) Provide community-based education programs to a minimum of 500 health professionals, 1100 health professions students and 4000 individuals throughout the state to increase awareness of the risks of opioid misuse disorder and strategies to appropriately prevent, detect, and intervene in opioid misuse behaviors. Data will be compiled and presented to demonstrate increased participant knowledge of opioid misuse disorders, behaviors, and treatment options.
