#### a. What specific purpose or goal will be achieved by the funds requested?

This project expands K12 Prep Academy's award-winning programs, including VR learning, CTE in aviation, cybersecurity, healthcare, NCAA-approved courses, Adult High School completion, and afterschool programs in STEM, financial literacy, and leadership. Our low-cost, 3D Learning Lab supports at-risk youth, special needs students, and adult learners, creating skilled graduates and higher-income taxpayers, strengthening Florida's economy.

#### b. What activities and services will be provided to meet the intended purpose of these funds?



We will provide K-12 education, Career & Technical Education (CTE) programs (Aviation, Cybersecurity, Healthcare, Construction, and Entrepreneurship), Adult High School completion, and immersive Virtual Reality (VR) learning. Additionally, we will offer afterschool programs focused on STEM, financial literacy, mentorship, arts, and leadership development ensuring workforce and college readiness.

#### c. What direct services will be provided to citizens by the appropriation project?

We will provide K-12 education, Career & Technical Education (CTE) programs (Aviation, Cybersecurity, Healthcare, Construction, and Entrepreneurship), Adult High School completion, and immersive Virtual Reality (VR) learning. Additionally, we will offer afterschool programs focused on STEM, financial literacy, mentorship, arts, and leadership development ensuring workforce and college readiness.

#### d. Who is the target population served by this project? How many individuals are expected to be served?

Persons with poor mental health, Persons with poor physical health, Jobless persons, economically disadvantaged persons, At-risk youth, Homeless, developmentally disabled, physically disabled, Grade school students, high school students, victims of crime

# e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

K12 Prep Academy uses VR learning, a 3D Learning Lab, and CTE programs to support at-risk youth, special needs students, and adult learners with career-focused training. Expected outcomes: 20% graduation rate increase, 35% more industry certifications, and 25% higher post-grad employment or college enrollment. Success is measured through graduation rates, job placement, FSSAT testing, progress monitoring, and school performance metrics. The 5-month Adult High School program accelerates workforce entry, while CTE programs in aviation, IT, and healthcare create high-paying job opportunities, reducing reliance on public aid. 80% of CTE graduates will secure employment or higher education within six months. Afterschool programs in STEM, financial literacy, and leadership provide structured alternatives to delinquency, reducing recidivism. This initiative will create 50+ jobs in year one, equip students with career-ready skills, and strengthen Florida's economy.
