The funds will allow for the design, planning, engineering and construction of a multi purpose emergency/community center facility.

### c. What direct services will be provided to citizens by the appropriation project?

The center will provide a safe haven for citizens during natural disasters and other emergencies and provide educational and job training programs. The center will be utilized by community organizations and the general public.

### d. Who is the target population served by this project? How many individuals are expected to be served?

The Glades area region. Capacity to serve 400 daily including beds, showers, laundry, food services, and meeting space. Capacity would be higher based upon enrollment of job training and other educational programs.

### e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

The center will provide the general public with a safe haven during natural disasters and emergency situations. In addition, local community-based non-profits and informal groups will use the facility for meetings and other special events that add to the vibrancy of South Bay. The facility will house a community kitchen and café that will be open to the public. The kitchen will serve as a training facility for adults and/or disabled/developmentally disabled adults to receive training in food preparation/service. Number of those seeking shelter, programming registration and completion rates.
