c. What direct services will be provided to citizens by the appropriation project?

Capital reconstruction of the roadway and the addition of new drainage and water utilities, increased public safety with sidewalks and streetlighting, and elimination of hazardous roadway flooding and restoring defunct hydrants.

d. Who is the target population served by this project? How many individuals are expected to be served?

Town of Belleair and Belleair Bluff residents, approximately 500 residents.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Increased water flow to existing southwestern hydrants, pavement condition index score for the roadway segment, a reduction in vehicular and pedestrian accidents, increased use of pedestrian pathways, improved storm water quality.

The applicant, Town of Belleair, will be barred from applying for further state funding for this project. Unspent allocations will be returned under a negotiated contract.
