This project is intended to help reduce the flooding of approximately 500 structures by the construction of a stormwater pond and pump station. Approximately 8,000 feet of pipe will also be installed to pump the stormwater directly to the Halifax River.

b. What activities and services will be provided to meet the intended purpose of these funds?

These funds will be used to install approximately 8,000 feet of pipe and construct a stormwater pond and pump station.

c. What direct services will be provided to citizens by the appropriation project?

The installation of 8,000 feet of pipe, along with the construction of a stormwater pond and pump station to pump flooding waters from neighboring subdivisions to the Halifax River.

d. Who is the target population served by this project? How many individuals are expected to be served?

The target population is approximately 500 residences that flooded during Hurricanes Ian and Milton. However, we also believe hundreds more will experience less water intrusion due to less water moving toward the Nova Canal system which was inundated during these storms.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Protection of the general public from the environmental hazards associated with flooding by reducing the flooding of structures. A comparison of the number of flooded structures before the project and after the project during similar storm events will be the method of measuring the success of the project.
