The Female Development World Organization (FDWO) seeks \$750,000 in state funding to combat two escalating threats: human trafficking and cybercrime. In 2023, Florida reported 41,061 cybercrime complaints, with \$874.7M in losses (FBI IC3), and human trafficking's economic impact at \$9B (FSU). This funding will position Florida as a leader in cybersecurity education, addressing 1.8M unfilled statewide jobs, combating human trafficking (ranked 3rd), and attracting tech companies. FDWO proposes an intensive 8-week Human Trafficking and Cybersecurity Certificate Program to create awareness among our youths and develop a skilled workforce capable of safeguarding Florida's communities, protecting critical systems, and combating exploitation in the digital age.

The requested funds will make Florida a leader in cybersecurity and human trafficking education, while creating a talent pipeline to attract tech companies and drive economic growth. Cybersecurity skills are vital for combating human trafficking, where Florida ranks third nationally. Traffickers exploit cybercrimes like identity theft and online recruitment. A cyber-trained workforce will disrupt these activities, ensuring Florida remains competitive, safeguards its communities, and tackles social and economic challenges effectively. This dual-purpose strategy strengthens the state's future security and economic resilience.

b. What activities and services will be provided to meet the intended purpose of these funds?

The program will equip Florida's youth with skills in cybersecurity and human trafficking prevention through an 8-week certificate program for 6th-12th graders. The curriculum covers cyber safety, cybersecurity basics, and human trafficking awareness, including recognizing trafficking tactics, cyberbullying, and emotional resilience. Guest speakers from cybersecurity and public safety sectors will provide real-world insights. High-achieving juniors and seniors can access dual enrollment at community colleges, while weekly progress reviews ensure personalized support. This experiential learning approach fosters a cyber-aware generation ready to navigate digital challenges and combat emerging threats effectively.

c. What direct services will be provided to citizens by the appropriation project?

This project provides critical education for Florida's youth (grades 6–12) and families, focusing on human trafficking awareness, cyber safety, and cyberbullying prevention. It promotes responsible digital citizenship and protects against online predators and traffickers. Additionally, it addresses the national cybersecurity workforce shortage, with 1.8 million unfilled positions, by preparing students for careers in this vital field. By tackling safety and workforce challenges, the initiative positions Florida as a leader in cybersecurity education, safeguarding communities and developing a new generation of cyber-savvy professionals ready to combat digital threats and protect the state's future.

d. Who is the target population served by this project? How many individuals are expected to be served?

The target audience is Florida students in 6th grade - 12th grade. Target populations include economically disadvantaged, at-risk youth, grade school students, high school students, current or formerly incarcerated persons, drug offenders (in criminal justice), and victims of crime.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

This project aims to improve mental health, enrich education, protect the public, and foster economic growth while creating jobs and reducing crime. It builds emotional resilience by addressing cyberbullying and teaching digital safety, empowering students with skills for success and protection against online threats. Graduates will gain pathways to cybersecurity careers, addressing workforce shortages and boosting economic self-sufficiency. The program also diverts at-risk youth from crime, reducing Florida's ranking as third in human trafficking. Outcomes will be measured through databases, life skills assessments, activity logs, quizzes, and surveys to ensure accountability, track progress, and support continuous improvement.
