13. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

The funds will enable the Estella Byrd Whitman Community Health Center to expand access to quality healthcare services, including primary care, chronic disease management, preventive screenings, and mental health support. By creating a dedicated radiology area, addressing healthcare disparities, and fostering community wellness through education and partnerships, we aim to improve health outcomes and ensure equitable, sustainable access to care for underserved populations.

b. What activities and services will be provided to meet the intended purpose of these funds?

The funds will support activities and services aimed at enhancing community health, including:

Primary Care Services: Comprehensive adult and pediatric care.

Chronic Disease Management: Diabetes, hypertension, and other long-term conditions.

Preventive Screenings: Cancer, mental health, and substance use disorder screenings.

Radiology Services: Onsite diagnostic imaging to improve access and reduce barriers.

Life Skills Training: Budgeting, job readiness, and employability skills to foster self-sufficiency.

Community Partnerships: Collaboration to address social determinants of health and reduce emergency room overuse. These services will provide integrated, accessible care to underserved populations, improving health outcomes and

promoting long-term community wellness.

c. What direct services will be provided to citizens by the appropriation project?

The appropriation project will provide impactful services to address critical community needs, including:

Comprehensive Primary Care: Accessible healthcare for adults and children.

Chronic Disease Support: Management and education for diabetes, hypertension, and similar conditions.

Preventive Health Services: Cancer screenings, mental health evaluations, and substance use interventions.

Onsite Radiology: Diagnostic imaging to improve access and reduce delays in care.

Life Skills Development: Training in budgeting, job readiness, and employability to foster economic independence. Resource Navigation: Connections to community partners addressing housing, food security, and transportation barriers. These targeted services will improve health outcomes, reduce disparities, and promote self-sufficiency for underserved

populations, ensuring the greatest return on investment for the community.

d. Who is the target population served by this project? How many individuals are expected to be served?

The target population for this project includes underserved and high-risk individuals in Marion County, particularly those facing barriers to healthcare due to socioeconomic challenges, limited access to services, or chronic health conditions. This includes adults, children, and families from diverse backgrounds who are uninsured, underinsured, or otherwise marginalized.

The project is expected to serve approximately 1,500 unique individuals annually, providing critical healthcare services and support to improve health outcomes and foster community wellness.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Expected benefits include improved access to healthcare, enhanced management of chronic conditions, and reduced reliance on emergency rooms for non-emergency care. Key outcomes include Improved Health Metrics: Increased percentage of patients with controlled HbA1c (<9%) and blood pressure (<140/90), and higher cancer screening rates for early intervention. Reduced Healthcare Costs: Fewer non-emergency visits to ERs, saving costs and alleviating system strain. Increased Self-Sufficiency: Enhanced employability and life skills leading to economic independence. Methodology for Measurement: Establish baselines for health indicators (e.g., HbA1c, blood pressure, cancer screenings). Track patient data, screenings, and medical encounters using the electronic health record system. Monitor patient outcomes from life skills and employability training through pre/post-assessments and employment records. Evaluate ER utilization rates to assess reduced recidivism.
