4. Project/Program Description

The project includes replacement of the three boats docks at Front Street Park in Melbourne, shoreline hardening for erosion control, minor milling and resurfacing of the parking lot near the boat ramp and an American with Disabilities Act compliant sidewalk and curb ramp with associated signage and striping. The project also includes ADA upgrades on one of the ramps to include a dock width of 5-feet to accommodate wheelchairs, extending the dock to meet the finish grade of the parking lot, installation of a guide rail for drop-off conditions and a ramp slope not to exceed 8.33%.

13. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

The Front Street boat docks provide important direct access to the Indian River Lagoon as one of two locations in Melbourne where boat launches with accessory docks are available to the public. High user demand and limited access to the Indian River Lagoon for recreational and commercial boaters makes this project a priority for the City of Melbourne. High water levels in the IRL has caused the boat docks to be closed several times due to being underwater and the new dock design will alleviate this issue and make them usable year round.

b. What activities and services will be provided to meet the intended purpose of these funds?



Local boaters as well as those traveling the intercoastal waterway will benefit from the reconstruction of the boat docks at Front Street Park. Reconstructing the docks with an ADA accessible ramp will allow more boaters safe access to the Indian River Lagoon, bringing more boaters through the area, stimulating the local Melbourne economy as well as other cities within the Space Coast. Residents from other counties have reasonable access to the public boat docks and ramp. The Front Street boat ramps and docks are also utilized by the Melbourne Police Department Marine Unit and Florida Fish and Wildlife to access the waterways for environmental protection, public safety, enforcing boating rules and regulations, natural resource protection, and other waterway/boating matters.

c. What direct services will be provided to citizens by the appropriation project?

The Front Street boat docks provide important direct access to the Indian River Lagoon. It is one of two locations in Melbourne where boat launches with accessory docks are made available to the public.

d. Who is the target population served by this project? How many individuals are expected to be served?

The target population of this project is recreational and commercial boaters for the local community and surrounding area. Since 2016, the Florida Department of Highway Safety and Motor Vehicles reported the total number of registered vessels for Brevard, Volusia, and Indian River counties was 72,605.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

be measured?

As a coastal city, our community has a high demand for public access to the waterways. Front Street Park is one of only two locations in Melbourne with boat launches with accessories that are available to the public. Reconstruction of the docks will help the City continue to satisfy the high demand while providing safe access to the Indian River Lagoon (IRL) for all users.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for in the contract?

City of Melbourne contracts include a liquidated damages provision in the amount of \$500 per day. This penalty is enforced when a contractor fails to complete the project within the contract time limits. If requested, this amount can be increased or decreased based upon State of Florida guidelines.
