Applying agentic AI teams to upskill participants and employees of non-entrepreneur organizations which allows us to scale support.

Entrepreneur education and simulation activities toward business growth. Online/In person training registrations, simulation event completions, customer development plans, and business model validation submissions. Pitch contest with opportunities, Supplier/vendor contract opportunity, Access to capital showcase (loan applications, pitches, and loans) to grow small business activity. Asset building and financial management. Modeling entrepreneur paths at the community level. Workshops, seminars, learning strategies, business strategy.

The target population served by this project are aspiring entrepreneurs in rural and urban areas, jobless persons, economically disadvantaged persons, University/College students, and currently or formerly incarcerated persons. We average over 300 applications per cohort every six months.

Business growth + entrepreneur participation. Online/In person training registers, simulation event completions, customer development plans, and business model submissions. Established entrepreneurial curriculum, assessments, and proven learning strategies. Cohort programming has been best way to scale small business participation. Pitch opportunities w/suppliers, The vertical integration of Al allows a State-Compute-Prescribe model to accelerate education, formation, strategy, planning, and commerce opportunities
