The goal of this project is to eliminate up to 33 septic tanks in a low lying area of the City of Atlantic Beach resulting in a reduction of fecal coliform bacteria and nutrients to area surface waters.

Direct services to be provided include connection to the City's public sewer system that will provide for a flood proof means of sewage disposal and the elimination of potentially failing septic tanks.

The target population to be served by this project are area residents relying on a septic tank and drainfield for sewage disposal. Ancillary benefits will be provided the general public by improving water quality in the saltmarshes of Atlantic Beach.

Elimination of septic tanks potentially contributing pollutants to the saltmarsh. The outcome will be measured by the number of septic tanks eliminated and improvement in water quality.
