4. Project/Program Description

R.E.S.T.O.R.E. is developing a quadplex transitional housing project to support formerly incarcerated women as they reintegrate into society. This project aligns with our mission to provide safe, stable & affordable housing, equipping women with the resources and skills necessary for independent living. The quadplex will serve as the next step in our housing continuum, offering a structured yet empowering environment for women transitioning toward complete independence.

We are proud as an organization to secure 75% of the required funding and only asking the state of Florida to assist us to reach the finish line of this project. Of the women that have successfully completed the existing project, exactly 0 women have recidivized and returned the Florida state prison system. This is saving Florida financially, reducing the prison population, increasing public safety, and ultimately bringing broken families back together as most incarcerated women are mothers.

13. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

R.E.S.T.O.R.E. is developing a quadplex affordable & transitional housing project to support formerly incarcerated women as they reintegrate into society. The quadplex will consist of four residential units including the following:

Two 2-bedroom units - designed for shared living to reduce costs and foster community Two 1-bedroom units - Intended for women preparing independent living or reuniting with their children.

b. What activities and services will be provided to meet the intended purpose of these funds?

Ability to provide Affordable housing options for formerly incarcerated women who have successfully completed the R.E.S.T.O.R.E. program. Residents must be employed full-time and demonstrate readiness for increased responsibility. This housing option prepares them for the final reintegration phase, including securing permanent housing and financial independence.

c. What direct services will be provided to citizens by the appropriation project?

Affordable & transitional housing along with wrap around services such as job placement, counseling, education assistance, and other services to support reintegration.

d. Who is the target population served by this project? How many individuals are expected to be served?

Formerly incarcerated women

be measured?

Affordable housing options for clients who have graduated from the R.E.S.T.O.R.E. re-entry program and are stepping up to independent living. Success outcomes are measured by monitoring recidivism, celebrating milestone achievements such as job placement & promotion, educational accomplishments, and reunification with family members.

A traditional construction project contract will be in place and agreed upon by both R.E.S.T.O.R.E. and the chosen licensed contractor. This contractor also has provided in-kind donation of waiving traditional general contract management & overhead costs for the entire project.
