Citizens and road users will be provided with significantly improved swales systems that will mitigate ponding and localized flooding on the residential roadways within their communities

This is a City wide project but the project will be focused on sections of the City where the target population is the elderly, economically disadvantaged and the general population that live and use the roads in the area, For example our historic east side neighborhoods.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

The project will improve safety on the roads and make it easier to traverse the road with less ponding of water on the roadway. this can be measured by the reduces number of road incidents due to rain events. It will also alleviate flooding and increase runoff storage an it can be measured with reduced incidents or complaints of ponding or flooding on the roads by residents. Stormwater runoff will also receive treatment in the swale prior to discharging to lakes and this can be measure by sampling of water and testing.
