4. Project/Program Description

This phase of the Peace Creek Water Preservation Project focuses on the protection of floodwater storage areas and providing an increase in storage capacity of excess water during extreme weather events near the Headwaters of Peace River. Through implementation of approximately 360 acres of floodplain, hydrologic, and ecologic restoration of lands, on the Wilson Ranch Reserve, the Headwaters of Peace River will have improved water quality, reduce invasive plant species, provide for additional floodplain, and restores wildlife habitat that was lost over time because of the site being ditched and drained for agricultural practices over many decades.

13. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?



With the proposed wetland restoration efforts described above, and protection of historic wetlands on along Peace Creek Canal, at a minimum of 400 +/- acres, it is anticipated that this regional project can provide around 6,000 acre-feet annually of storage near the headwaters of the Peace River. The increased floodplain and wetland storage capacity projects will ultimately perform as passive wetland treatment systems providing water quality improvements through attenuation of the waters moving from Peace Creek to the Peace River.

b. What activities and services will be provided to meet the intended purpose of these funds?

Floodplain and stream restoration construction activities will include invasives treatment, planting and installation of best management practices. Contractor oversite implementation. Acquisition of historic wetlands from willing landower along Peace Creek Canal.

c. What direct services will be provided to citizens by the appropriation project?

Future components of the Project will involve construction of recreational and educational enhancements at the Project Location.

d. Who is the target population served by this project? How many individuals are expected to be served?

The population served by this Project will be nearby landowners experiencing a reduction of flood depths and velocities during high water events and downstream constituents experiencing improved water quality downstream of the project location. Additionally, students and nature enthusiasts will be served by the recreational and educational components to be incorporated into the Final Project.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

be measured?

The estimated net water quantity benefit is proposed to improve flood resilience within the watershed and provide greater connection of the Peace River to the historical flood plain through the removal of approximately 7,000 LF of berm that runs along the south/east side of Peace Creek and protection of over 400 acres of historic wetlands.
