13. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

Keystone Properties has invested hundreds of millions of dollars in private investment to develop and maintain the properties and surrounding areas. The specific purpose of these funds being requested is for the planning, design and constructions of a vehicular overpass at Wigmore Street in Jacksonville, Florida. The project allows for the installation of a crossing over the recent expansion of at-grade railroad crossings on Wigmore Street. The continued improvements will provide increased safety elements for the surrounding community. Without the construction of the overpass, the four at-grade railroad crossings and pedestrian safety issues.

b. What activities and services will be provided to meet the intended purpose of these funds?

The proposed vehicle overpass will provide for improved vehicular and pedestrian traffic patterns thus creating safer travel movements for those utilizing the overpass. The overpass will ultimately reduce pedestrian/vehicle traffic encounters and thus reduce accidents. The construction of this overpass will also strengthen and improve the stormwater management system within the affected area. The lighting on the overpass will illuminate the surrounding areas and enhance public safety.

c. What direct services will be provided to citizens by the appropriation project?

The direct services to the citizenry are specific and include the relieving of vehicular and pedestrian traffic congestion on Wigmore Street and the surrounding areas. With the expansion at the Port of Keystone and current railroad conversion projects, the overpass will become important as a service to the community and users. This project will improve the quality of life through improved mental and physical health, increased safety mechanisms and improvements in surrounding stormwater systems among a myriad of other services.

d. Who is the target population served by this project? How many individuals are expected to be served?

The target population includes the entire city but provides specific benefits to those residents that currently reside in the surrounding under-served community. Thousands of individuals will be served by this project on a daily basis. Both residential and commercial traffic continues to grow in tandem with the growth of the area.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

The benefit of this project will have a measurable impact on both vehicular and pedestrian traffic congestion as well as increased safety for all users. Pre and post construction data will be collected on Wigmore Street to reflect these improved conditions. Methods for measuring level of benefit will include standard traffic counts and times at and around the overpass, as well as railroad counts and times for the four at-grade rail lines which run underneath the overpass.
