K9 Partners for Patriots, Inc. is seeking state funding to implement and expand a comprehensive mental health counseling, animal assisted therapy, and service dog training program for veterans diagnosed with Post-Traumatic Stress Disorder (PTSD), Traumatic Brain Injury (TBI), and Military Sexual Trauma (MST). The goal is to restore independence and freedom by improving mental health, reducing suicide rates, sustaining recovery from substance abuse, and empowering veterans through enhanced emotional regulation and vocational integration, fostering self-sufficiency, and long-term success in civilian life.

### 13. Program Performance

### a. What specific purpose or goal will be achieved by the funds requested?

The funds will support Operation Resilience, which offers mental health counseling, animal-assisted therapy, and service dog training to veterans with PTSD, TBI, and MST. The goal is to restore independence and freedom by improving mental health, reducing suicide rates, sustaining recovery from substance abuse, and empowering veterans through enhanced emotional regulation and vocational integration, fostering self-sufficiency, and long-term success in civilian life.

### b. What activities and services will be provided to meet the intended purpose of these funds?

The activities provided include trauma-informed mental health counseling, animal-assisted therapy, service dog training, and biometric tracking. Veterans will engage in weekly counseling and therapy sessions, service dog training that enhances emotional regulation and social mobility, and real-time biometric monitoring for long-term symptom management.

#### c. What direct services will be provided to citizens by the appropriation project?

The funding will provide veterans with PTSD, TBI, and MST access to mental health counseling, animal-assisted therapy, and service dog training. Services include individual and group therapy, biometric symptom tracking, telehealth access, veteran travel assistance, and aftercare programs, ensuring long-term stability, crisis prevention, and improved quality of life.

### d. Who is the target population served by this project? How many individuals are expected to be served?

The target population served will be U.S. Military Veterans with a diagnosis of PTSD, TBI, and MST, Including rural and low income veterans. We expect to serve up to 800 Veterans. We currently have 782 active Veterans enrolled in our program and our program grows every month.

### e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Expected Outcomes: Reduction in symptoms of PTSD, TBI, and MST among participating veterans, as measured by standardized assessment tools. Increased engagement in mental health care, with high levels of satisfaction reported by veterans and their families. Strengthened familial bonds, leading to better reintegration into civilian life and improved quality of life for veterans and their families. Reduced suicidal ideation among program participants. Reduction in symptoms of PTSD, TBI, and MST among participating veterans, will be measured by standardized assessment tools and tracked by researchers with the University of Central Florida.

If the contractor fails to meet key performance benchmarks, they must submit a Corrective Action Plan (CAP) within 30 days, detailing deficiencies, solutions, and a timeline for correction. If issues persist, the agency may withhold 10-20% of the next payment until improvements are verified. Continued noncompliance may result in contract termination for cause, ensuring funds are redirected to providers who can meet deliverables and maintain program integrity.
