4. Project/Program Description

For over 30 years, BSI has been headquartered in the heart of South Dade, serving as a trusted resource for families in need. However, the current facility structure is inadequate to meet the growing demand of the 11,000 families served annually. BSI seeks to renovate its 4,536 sq. ft. facility into a one-of-a-kind community safe haven. This renovation project will establish Be Strong Village, a space designed to provide comprehensive wraparound services that strengthen families and promote self-sufficiency. This village will offer a supportive environment where families can access critical resources, build resilience, and work toward long-term stability.

BSI is seeking support to renovate its facility as a one-of-a-kind community safe haven offering comprehensive wraparound services that strengthens families and promotes self-sufficiency. Headquartered in the heart of South Dade for over 30 years, BSI recently purchased its 4,536 sq.ft. office and the existing facility structure does not meet the demand of the 11,000 families served yearly. This initiative will empower Be Strong Village to provide integrated, traumainformed care to families.

b. What activities and services will be provided to meet the intended purpose of these funds?

The facility will empower families, strengthen relationships, and promote long-term family stability, ultimately reducing the risk of child abuse, neglect, and family disruption.

c. What direct services will be provided to citizens by the appropriation project?

Families will be able to access comprehensive family-strengthening services such as complimentary parenting education & support through evidence-based and evidence informed strategies, youth development services, case management and care coordination services, and trauma informed support to help vulnerable populations build safe and stable family environments.

d. Who is the target population served by this project? How many individuals are expected to be served?

Families in crisis, Elderly persons, persons with poor mental/physical health, economically disadvantaged persons, atrisk youth, homeless, grade school students, high school students, university/college students, victims of crime

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

be measured?

Be Strong Village will serve as a safe haven with community benefit measured by: 1) Centralizing services for 11,000 families annually measured by client intake and enrollment assessments; 2) Improving access to parenting skills, youth development services, and family engagement opportunities as measured by parenting skills surveys and family engagement surveys; and 3) Improved access to care coordination that links heads of households to mainstream benefits and employment resources measured by BSI's data management system.
