4. Project/Program Description

To create 2 Museum exhibits to tell the story of each of the iconic HDEC's anchor artifacts during the Holocaust. In 2007, the HDEC acquired a Railcar from the Polish government. After an extensive restoration process, German designation numbers were revealed on the undercarriage of the Railcar. As a result, the Railcar was identified as a Karlsruhe number 37657 G. This Railcar transported men, women, and children from the Warsaw Ghetto to the Treblinka Death Camp. A steel floor will be put over the Railcar floor and an elevated platform and stairway as well as a wheelchair lift, for handicap accessibility, will allow visitors to walk through the Railcar and have a unique opportunity to view the interior. The HDEC has also acquired a U.S.M-4A3E8 Sherman Tank of the type that was used during the liberation of the Dachau concentration camp. The Sherman Tank which was on permanent loan from the United States Army has just been gifted to the HDEC.

13. Program Performance



a. What specific purpose or goal will be achieved by the funds requested?

The goal is to create two permanent exhibits for the HDEC's two anchor artifacts, the Railcar and the Tank, that will enrich and enhance the visitor museum experience. In addition visitors will have the opportunity to learn more about the significance and importance of these two artifacts. Visitors will also have the profound opportunity to walk in and through the Railcar.

b. What activities and services will be provided to meet the intended purpose of these funds?

These two exhibits of the Railcar and Tank will be a part of the HDEC full museum experience which is open to all visitors and school field trips. In addition, any programs, films, events, and traveling exhibitions at the time will also be available for touring.

c. What direct services will be provided to citizens by the appropriation project?

All citizens will be able to schedule tours of the museum, visit the Library, the Interactive Learning Center, become a volunteer such as a transcriber, audit editor, proofer of the HDEC's globally recognized Oral History Collection of Survivors, Liberators, and Rescuers eyewitness testimonies which to date total 2300+. Visitors will also be able to access the 59,000 eyewitness testimonies from the USC Shoah Foundation, which was founded by Stephen Spielberg. Citizens will also be able to schedule Speakers from the HDEC Speakers Bureau for their community organizations, foundations, schools, and universities.

d. Who is the target population served by this project? How many individuals are expected to be served?

Students from elementary through college and universities, elderly, Holocaust Survivors and their families, historians, authors, scholars, researchers, representatives of Holocaust museums, locally nationally, and internationally, educators, and legislators. The HDEC anticipates to serve over 36,000 individuals.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

be measured?

The Railcar and the Sherman Tank are a unique artifact grouping, exclusive to the HDEC. The Railcar which is a "cattle car" gives visitors an insight to the conditions of what it was like for human beings to be transported to the concentration camps during the Holocaust and the US Sherman Tank tells the story of the Liberation of the Dachau Concentration Camp, by the US Army. These two artifacts will be situated side by side in the Museum, thus presenting the two absolute stark contrasts of the Tragedy and the Triumph. The methodology by which this outcome is measured are the evaluations forms that are given to every visitor to complete.
