#### 13. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

Project #1 will be the Oral History of our great Florida Veterans, whose stories will be shared free with classrooms across Florida. Project #2 will improve Life-Safety by replacing our Fire Escape Stairs with permanent metal stairs. We are committed to providing a museum safe for all visitors, especially the disabled, who too frequently are Veterans.

b. What activities and services will be provided to meet the intended purpose of these funds?

Project #1. We will provide offices, gather the Oral Histories of Florida's Veterans, and create them, with DVDs going to the US Library of Congress, the State of Florida and its school districts.

Project #2. We will build permanent outdoor Fire Escape Stairs of metal, in keeping with all codes, permits, inspections and approvals that will last for ages.

c. What direct services will be provided to citizens by the appropriation project?

Recording a Veterans Oral History Program, especially for those Veterans who suffer PTSD, has proven to be therapeutic. A sense of closure and reconciliation by former soldiers is vitally important. Feedback from Veteran participants in the Oral History Program to both the Military Museum and the FL Dept. of State will insure that the program is achieving maximum benefit.

d. Who is the target population served by this project? How many individuals are expected to be served?

Miami-Dade County alone has 70,000 Veterans. Florida has 1.5 million Veterans. Florida hosts 21 major military bases, including Southern Command, Central Command, Special Operations Command, Mayport (4th Fleet HQ), NAS Key West, Eglin AFB, Patrick Space Force Base. Thousands of students in the JROTC here are learning and being inspiring by true stories of our military heroes. We host very popular Remembrances including D-Day, 9-11 Day and Pearl Harbor Day, as well as national Days of Observance such as MLK Day, Memorial Day, 4th of July and Veterans Day. These patriotic events are Free and open to the public. We have been honored by such officials as Lt. Gov. Jenette Nunez and our American Secretary of State, Honorable Marco Rubio, as well as soldiers, military commanders and many elected officials.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Being able to share videos of our own Florida military heroes can only enrich our common cultural experience and directly impact draw to the Museum, as well as to our immediate neighbors: Zoo Miami and the Gold Coast Railroad Museum. Heritage Tourism is an increasingly important aspect of the attraction of Florida to national and international travelers. Our Museum Building is nationally recognized as historic. We hope to work together to recognize our own FL Veterans themselves.
