The CAD/RMS System utilized in the City of South Miami Police Department is twelve (12) years old and in need of replacement. The Computer Automated Dispatch/Records Management System (CAD/RMS) is a comprehensive technology solution designed to enhance the operational efficiency, accuracy, and response times of the Police Department. This system will integrate dispatch, communication, and records management functions into a unified platform, allowing for streamlined coordination of law enforcement services, better decision-making, and improved public safety outcomes. The CAD component will automate emergency and non-emergency call processing, dispatching of officers, and resource tracking, while the RMS component will store, manage, and retrieve case files, incident reports, and other critical law enforcement data.

Centralized Record Keeping: The RMS will centralize and digitize incident reports, arrest records, case files, and other law enforcement data, making it easier for officers and staff to access, update, and manage records quickly and securely. Data-Driven Decision Making: The system will facilitate the analysis of trends and patterns, allowing for better resource allocation, predictive policing, and proactive crime prevention efforts.

Compliance and Accountability: The CAD/RMS will help ensure the department meets legal and regulatory requirements by providing accurate documentation and streamlined reporting capabilities for audits, investigations, and public record requests.

System Implementation and Integration: Funds will be used to procure and implement the CAD/RMS software, ensuring it is fully integrated with existing communication systems, databases, and technology infrastructure within the PD. Staff Training: Comprehensive training will be provided for officers, dispatchers, and administrative staff to ensure effective use.

Faster Emergency Response: The implementation of the CAD system will enable quicker and more accurate dispatching of officers to emergency situations. Citizens will benefit from faster response times during critical incidents, such as accidents, medical emergencies, or crimes in progress, leading to potentially life-saving outcomes. Enhanced Public Safety: The CAD/RMS will enable officers to access real-time information about ongoing incidents, prior reports, and local crime patterns. This will allow for more proactive and informed policing, which can prevent crimes, reduce response times, and ensure safer neighborhoods. Enhanced Communication with Citizens: The system will support better communication between officers and the public, as the CAD system's real-time data can improve dispatching and allow for clearer, more accurate updates on incidents. Citizens will benefit from enhanced communication, including timely updates about responses to calls or incidents in their neighborhoods.
