4. Project/Program Description

The Mustard Seed operates a furniture program for families emerging from hardship, such as homelessness, personal tragedy, or natural disaster. The cost to The Mustard Seed to render services to each family is \$717, which includes case management, program documentation through the agency's client specialist, and funding for the agency's transportation department, which picks up donations to provide to clients. The requested funding will provide 105 families with all of the furniture that they need to make their house a home (15-25 pieces).

13. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

105 families in the Central Florida area will be provided basic household furniture, including beds, tables, couches, etc. as they emerge from situations of crisis such as homelessness/natural disaster. To provide 15-25 pieces of furniture to families in need, The Mustard Seed incurs a cost of \$717, which encompasses programmatic costs to support staff who administer the program, as well as associated costs in receiving furniture donations from the community. The goal would be to support dignity in transition for families in need.

b. What activities and services will be provided to meet the intended purpose of these funds?

Activities and services included will be providing the furniture program to families in the Central Florida area emerging from crisis.

c. What direct services will be provided to citizens by the appropriation project?

For families emerging from situations of homelessness, personal tragedy or natural disaster, basic household furniture will be provided to the household once they have acheived stable housing. Funding provided by the state of Florida will provide 105 families with 15-25 pieces of furniture.

d. Who is the target population served by this project? How many individuals are expected to be served?

The target population is primarily economically disadvantaged families who have experienced homelessness, and individuals and families who have lost their personal belongings to a natural disaster. 105 families will be provided with furniture, which is an estimated 200-400 individuals.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

be measured?

When families are emerging from crisis, it is difficult to adequately furnish their homes with limited financial resources. The Mustard Seed seeks to restore dignity to families by providing basic household furniture. The benefit to the children in the home is substantial, with parents reporting that children's quality of sleep has improved, and that 85% of families served report an improvement in their children's grades in school. The methodology of these statistics is conducted through a pre/post survey provided at time of service as well as six months post.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for in the contract?

If the organization fails to meet the goal of serving 105 families with the funding provided by the state of Florida, the remaining funds will be returned to the state.
