This will also make the former spaces available for much needed classroom space for our fast-growing student population. Updating the existing outdated facilities to catch up to technology innovations since the original construction for operating cost efficiencies.

The new one-stop student services area will include admissions, academic advising, financial aid, learning support, and student clubs/activities. These functions are important to student success and retention and support the student through their lifecycle.

Lake-Sumter State College offers associate degrees, bachelor's degrees, and workforce credentials to individuals in Lake and Sumter Counties in support of meeting local workforce needs and connecting students with opportunities in their community.

LSSC serves over 9,000 students of all ages in Lake and Sumter Counties each year. Nearly 40% (3,600+) of these students attend or utilize services on the South Lake Campus in Clermont. This number continues to grow with expected student population growth at this campus forecast to be 10-15% each year for the next five years.
