13. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

Sudden cardiac arrest (SCA) is the leading cause of death in young athletes. These are devastating events with tremendous impact on the family, local communities, schools, and athletic teams. American Heart Assoc estimates that Statistical out of hospital cardiac arrest survival is around 10%. A focused effort on cardiac arrest preparedness in schools is critical to protect our children & others in the communities across the state. Nicklaus Children's is affiliate of Project ADAM, with mission is to serve children and adolescents through educational, life-saving programs that help reduce SCA mortality.

b. What activities and services will be provided to meet the intended purpose of these funds?

in 2024, Nicklaus trained all Miami Dade Public Schools to be prepared during such events & are currently training Palm Beach County Public Schools. This will expand our training to 200 additional school in our state. Nicklaus will work closely with DOE to identify a number of key public-school systems

c. What direct services will be provided to citizens by the appropriation project?

Nicklaus Children's will work closely with DOE to identify a number of key public-school systems that can benefit greatly from the expert training by Nicklaus to continue to implement life-saving training and education programs at identified schools throughout the State. We aim to train 200 additional schools with these funds. Studies demonstrate best chance of saving a life is in first 4 minutes of a SCA. Survival to hospital discharge for SCA in kids ages 1 to 11 is 17% & kids ages 12 to 18 it is 24%. Reducing time to defibrillation improve survival by 7-10% per minute. Early & effective CPR shows double or triple the chance of SCA survival. Where CPR/AED administered 85% students survive

d. Who is the target population served by this project? How many individuals are expected to be served?

Public School Systems (200 schools, its staff, students). Our training saved 9 lives in the last 2 years. At end of 2024, HEARTS Act of 2024, passed in Washington-Promoting Student Access to AEDS & CPR-Demonstrate an ability to develop, train, & implement comprehensive program to promote student access to defibrillation in public elementary & secondary schools. This funding will allow Nicklaus to expand our training further & guicker and could set up FL's elementary & secondary schools & sports programs to potentially receive federal support for these activities in the near future. It will also allow FL to be a national leader in this space.



The skills on how to respond with communication, CPR, use of an AED In order to pass the cardiac emergency response drill, school faculty must demonstrate as a team: response to the victim, CPR, and AED use with the 1st shock delivered in < 3 minutes to receive "Heart Safe Recognition" Improved cardiac arrest survival in schools that receive this training Schools that receive training will be logged in a password protected server and information via RedCap QR code to notify the Project ADAM team if a cardiac arrest occurs on school campus -Methodology to measure outcomes quantified via • Methodology to measure outcomes is a quantified via (# of SCA on school campus/ #SCA survived)

Quality of the education material and PA instructor led training is measured via a 5 question post RedCap survey
