The project will install / retrofit drainage structures on SW 37 Ave, from SW 24 Street to SW 20 Street. The drainage improvement work includes the construction of a stormwater drainage infrastructure with the installation of 300 linear feet of exfiltration trenches, solid drainage pipes, manholes and 8 drainage inlets in the public right-of-way, implementing new technologies for filtering and screening of stormwater as applicable. The project area located is in unincorporated Miami-Dade County.
