Revitalize outdated academic environments to meet contemporary industry standards. Upgrade laboratory facilities with advanced state of the art technology, expand capacity for STEM-related academic programs and research initiatives, and enhance FMU's capability to attract and retain top tier faculty and students in STEM fields.
