4. Project/Program Description

The construction of 3 disaster resilient homes and 10 roof repairs or replacements for families earning less than 80% of the area median income with a preference for veterans, first responders, healthcare workers, or education workers. Habitat Hillsborough homes are built to be resilient to hurricanes. We build homes with hip roofs, outswing exterior doors, they do not have any large exterior overhangs, ceramic tile, and they are equipped with hurricane shutters.

Upon completion of their home and our program, they will take title to the property. Roof repairs/replacement will require a 5-year lien against the homeowner's property.

a. What specific purpose or goal will be achieved by the funds requested?

3 low-income households will be provided with an affordable mortgage (no more than 30% of their income) that will allow them to become homeowners and break the cycle of poverty. 10 families will provided with roofing services to protect them from weather related disasters.



b. What activities and services will be provided to meet the intended purpose of these funds?

Habitat Hillsborough will purchase the land and construct 3 hurricane resilient homes for low-income families. In addition, Habitat will provide them with a zero percent interest mortgage and the education to ensure they are homebuyer ready. Such education includes a HUD certified housing counseling class, financial and home maintenance classes. 10 families will be provided with roof repairs/replacement with a 5-year lien against their property, in addition they will be invited to participate in the Habitat education curriculum.

c. What direct services will be provided to citizens by the appropriation project?

Affordable homeownership or retention and education.

d. Who is the target population served by this project? How many individuals are expected to be served?

Households that earn less than 80% of the area median income. We expect that at least 25 individuals will be served. A preference will be in place for veterans, first responders, healthcare workers and education workers.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

3 families will have financial security and the ability to gain generational wealth, therefore breaking the cycle of poverty. 3 hurricane resilient homes will be built, and an affordable mortgage will be provided. 10 families will gain the ability to stay in their homes due to roofing projects. 10 liens will be placed on the homes for 5 years.
