4. Project/Program Description

The Lake City Fire Department is requesting funding to replace its aging frontline fire engine at the Lake City Public Safety Building. This engine, which serves the historic district and responds to the highest number of calls, is nearly 14 years old and has required extensive repairs in recent months. A new fire engine will enhance emergency response reliability, improve public safety, and ensure firefighters have the necessary equipment to protect the community efficiently. Funding this replacement is critical to maintaining effective fire protection services for Lake City residents.

The funds will support fire suppression, emergency medical response, and rescue operations by replacing the aging frontline fire engine. The new engine will enhance response times, reliability, and firefighter safety while ensuring effective protection for the historic district and the broader community. It will also reduce maintenance downtime, allowing the Lake City Fire Department to maintain consistent emergency services, improve operational efficiency, and better serve residents in critical situations.

c. What direct services will be provided to citizens by the appropriation project?

The appropriation will provide enhanced fire protection, emergency medical response, and rescue services to Lake City residents. Replacing the aging frontline fire engine will improve response times, reliability, and firefighter effectiveness, ensuring rapid and efficient emergency services. Citizens will benefit from increased public safety, reduced risks from fire-related incidents, and improved emergency preparedness, particularly in the historic district and high-call areas served by the Lake City Fire Department.

d. Who is the target population served by this project? How many individuals are expected to be served?

The project will serve the residents, businesses, and visitors of Lake City, particularly those in the historic district and surrounding areas. The Lake City Fire Department responds to thousands of emergency calls annually, directly impacting approximately 12,000 residents within city limits and an additional 70,000 individuals in the surrounding Columbia County area. This investment ensures faster, more reliable emergency response services for the entire community.

be measured?

The project will improve emergency response times, enhance firefighter safety, and ensure reliable fire protection for Lake City. A new fire engine will reduce maintenance costs and downtime, increasing operational efficiency. Outcomes will be measured through response time data, service call volume, equipment maintenance records, and citizen satisfaction surveys. These metrics will assess the engine's impact on emergency services and overall public safety in the community.
