4. Project/Program Description

As members of the Voluntary Organizations Active in Disaster (VOAD) and local VOADs, the Florida 211 Network (408.918, FS) partners with the Florida Division of Emergency Management and local Emergency Management agencies as a 24/7 access point for disaster preparedness and response. When Hurricanes Helene and Milton hit Florida back-to-back, requests for disaster relief to Florida's 211 network surged by 40%. To effectively manage call surges and seamlessly collect, store and report real-time data to state and local agencies during natural and other disasters, state funding would support the one-time costs of purchasing and installing a unified statewide data and communications platform. By strengthening interoperability between 211 providers, this central and standardized communications platform will allow all 211 providers to reroute emergency calls to any other 211 provider during a disaster, streamlining the delivery of services and information to the public during emergencies.

13. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

The program aims to enhance the communication of emergency services and information to the public by improving interoperability among 211 providers. This initiative enables FLAIRS and the 211 Network to fulfill the statutory mandate outlined in Section 408.918, F.S. Implementing a centralized and standardized communications and data platform will deliver consistent, efficient, and cost-effective services to state and local agencies and residents during emergencies and natural disasters.



b. What activities and services will be provided to meet the intended purpose of these funds?

An integrated 211 communications framework will increase scalability during local or statewide disaster events to assist callers, regardless of their location; consolidate resource and referral data into a unified system; and strengthen the state's ability to target resources to vulnerable populations during emergencies.

c. What direct services will be provided to citizens by the appropriation project?

State funding will improve 211 service delivery to meet state and community objectives to respond effectively to citizen needs. The funding will support 24/7 access to real-time referrals for housing, food, mental health, and crisis services, assisting over 1 million citizens annually. It will enhance service delivery through faster response times, omnichannel access (phone, SMS, chat). Upgrades will support accurate targeting of resources, improving efficiency and outreach to seniors and those with special needs during disasters.

d. Who is the target population served by this project? How many individuals are expected to be served?

All citizens across the state that need information and referral services and support. Over one million Florida residents reach out to 211 each year.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Streamline resource matching and improve referral accuracy during disaster recovery, ensuring individuals can quickly access employment opportunities, job training, and financial aid programs to rebuild livelihoods. This will be measured by outcome surveys and referral completion. Data collection, analysis, and sharing will better prepare the state to target resources to meet citizen needs during emergencies and natural disasters.
