Once fully implemented, recurring funds will support the full-time Board Certified Behavior Analyst (BCBA), Accelerated Learning Center Director, and two Precision Teachers for direct education services. Consulting will be reduced to 6 hours per month, with additional training and coaching needs met by the BCBA and Center Director. Future funding may come from grants, private donors, or reallocated state funds from cost savings achieved through improved operations and youth services.

Key responsibilities include creating protocols to incorporate data dashboard insights into daily operations, managing project budgets and deliverable development, and facilitating communication among stakeholders. | 70,984 |

| Salary and Benefits | To address challenges related to complex youth behavior issues, funding will support one full-time Board Certified Behavior Analyst (BCBA) with experience in Multi-Tiered Systems of Support (MTSS). The BCBA will establish an MTSS program to address individual youth behavioral concerns and deliver evidence-based interventions, such as Applied Behavior Analysis. This position will be filled by a BCBA with prior experience in juvenile justice settings. | 110,847 |
| Expense/Equipment/Travel/Supplies/ Other | Additional expenses and supplies include specialized curriculum and resources tailored for students needing learning accommodations, as well as funding for incentives—such as special activities and snacks—for youth and staff who meet individual and group goals. 13. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

The goal of these funds is to implement the Outcome-Based, Science-Informed (OBSI) Service & Education Model in Juvenile Justice residential facilities to improve youth outcomes and enhance facility operations, including safety, security, and staff retention. The funds will also support the establishment of an Accelerated Learning Center to help students who are two or more grade levels behind catch up academically and the development of a customized virtual dashboard to facilitate data-driven decisions regarding youth and facility needs.

b. What activities and services will be provided to meet the intended purpose of these funds?

Funding will support behavior science-informed interventions, such as Applied Behavior Analysis (ABA), for youth with unique behavioral needs. Intensive educational services will be provided to students who are more than two grade levels behind. Additionally, facility staff and administrators will receive direct training and coaching through a behavior science-informed performance improvement framework to enhance their skills and effectiveness.

c. What direct services will be provided to citizens by the appropriation project?

For youth, behavior interventions use individualized plans to teach skills and strategies for managing difficult situations, while the Accelerated Learning Center enables learners to progress at their own pace and achieve academic success. Addressing the needs of youth with special behavioral and educational challenges enhances safety for all, reducing facility disruptions and enabling more time for programs that benefit all youth. Staff training, including workshops, follow-up coaching, and data-based feedback, will ensure improved competency and consistency in safety and security operations.

d. Who is the target population served by this project? How many individuals are expected to be served?

The target population directly served by these funds includes residential facility staff receiving regular training and support, as well as incarcerated youth benefiting from expanded behavioral services and specialized educational support within the facilities. These direct services are expected to impact up to 200 youth and 100 direct floor staff and administrators. Indirectly, the improved and expanded services will positively affect youth success upon returning to their local communities and schools, contributing to lower recidivism rates and safer communities.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

The OBSI Service Model will deliver significant benefits for both facility operations and youth outcomes. For facility operations, benefits include reduced injuries, improved staff retention, less understaffing and overwork, enhanced staff wellbeing, fewer youth behavioral issues, and more positive staff-youth interactions. For youth, the model will provide improved mental and behavioral health services, accelerated learning and increased support for youth with special education needs, more time for activities for all youth, and fewer youth and staff related incidents. Outcomes will be tracked before, during, and after injuries and compared to similar facilities. The project will also generate taxpayer savings by reducing costs for injuries, workers' compensation, overtime, and excessive turnover. Ultimately, the cost per youth per year will decrease while delivering better outcomes for youth and facility operations.
